# MEETING NOTES Human Rights City Alliance & Partner Groups- Follow-up meeting to the Summit vs. Racism 2017 February 1, 2017

Introduction to the Human Rights City Alliance and the global Human Rights Cities movement. People around the world have been organizing locally to demand that public officials better protect residents' basic rights, following the *Universal* (*i.e.*, *no borders*) *Declaration of Human Rights*. Pittsburgh City Council passed the Human Rights City Proclamation in 2011, becoming the 5<sup>th</sup> Human Rights City in the United States. The Human Rights City Alliance is working to build broad alliances of human rights defenders to hold public officials accountable to human rights standards. Working groups met on the following issues, which represent the work and leadership of the <a href="Human Rights City Alliance Steering Committee">Human Rights City Alliance Steering Committee</a>: Immigrant rights, housing justice, womens rights/gender justice, and police accountability/criminal justice reform. The groups focused on key projects and ways for people to get involved to defend some of the most vulnerable groups in our community and build a society based on human rights.

**Immigrant rights breakout group**, facilitated by Monica Ruiz (Casa San Jose), Antonia Domingo (LCLAA) 25 people in attendance

Events of last week have been especially traumatizing and scary for undocumented and immigrant community

- Discussed campaign for Martin Esquivel-Hernandez-he has not yet been released and work continues to stop his deportation.
- Discussed Sanctuary City and how this relates to Pittsburgh's being a Human Rights City
  - The city government agrees not to cooperate with ICE, in a variety of ways (refuse to turn people over wo warrant, some refuse to share police data, some refuse to turn people over without a specific crime)
    - The term sanctuary city has become politicized, so people are preferring other terms like "welcoming city", or "4th amendment city"
    - White House executive order blocks federal grants to cities with sanctuary policies- Other cities are uniting to resist this, there are <u>questions about its</u> <u>legality</u>
  - o Dan Gilman's efforts in city council to strengthen existing city commitments to protect immigrants in the city.
    - language access program
    - promise that no govt services would be denied
    - commitment to DACA
    - Pgh currently has unofficial/unwritten policy not to turn people over to ICE unless unless they are charged with particular crimes. Gilman's legislation strengthens this.
  - o There are 90 police departments in Allegheny County, we *need county-wide policy*

 WHAT CAN FOLKS DO? The Human Rights City Alliance and allies will keep folks informed about local policy and opportunities to help support immigrant protections.

## May Day march planning

- Annual May Day march has been a focus for immigrant rights/solidarity organizing since early 2000s mass mobilization by immigrants. This year we want to make this march HIGHLY VISIBLE and BIG. Bridging all groups around the city around immigrants, worker rights, and human rights generally.
  - series of events leading up to march
  - Current leaders most tied to Latino community, we need to be more inclusive of other communities
  - Location/ plans to link with Women's March Organization --organizing marches nationally on May 1
- o May Day weekend Popular education activities—need to Connect march agenda to ongoing action, advocacy. Big march can be an opportunity to mobilize
  - Teach-in on Sat. or Sunday June 29 /30--get people together to talk about/learn about issues—Also-more time for folks to network and learn about the work of different groups than is possible at a march. Teach in would build up to the Monday May 1 march.
  - Other linked events, i.e., service events, political advocacy
    - National actions in Washington DC planned April 29 (climate) and May 6 (Immigrant rights)
  - Invite public officials to march and other activities
- Other activities/ ongoing
  - o **Human Rights Messaging:** lawn / window signs—i.e., church/ schools/ other group projects to make signs of welcome/inclusion/love.
  - o call reps, mayor call and thank people doing good work--local reps never hear from constituents
  - o <u>How to help immigrant neighbors</u>-5 steps anyone can take
